RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AGREEMENT ("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in the Soccer activity ("Activity"), I, for myself, my personal representatives, assigns, heirs, and next of kin:

Acknowledge, agree, and represent that I understand the nature of Soccer activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

FULLY UNDERSTAND that: a. Soccer activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis, and death ("risk"); b. there risks and dangers may be caused by my own actions or inactions, the actions or inactions of other participating in the activity, the condition in which the activity takes place, or the negligence of the "releases" named above; c. there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation or that of the minor in the activity.

Hereby release, discharge, and covenant not to sue the CORTLAND SPORTS COMPLEX, INC., their respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the activity takes place, (considered releases herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, any of the releases, I will indemnify, save, and hold harmless each of the releases from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.
